PAGEANT RULES

To maintain discipline and order, we suggest you follow instructions during rehearsal/practice and all related events. There are reasons for each and every decision the committee makes. TRUST US! Please read the following pageant rules carefully, sign the **REGISTRATION FORM AND RELEASE OF LIABILITY FORM. RETURN REGISTRATION FORM (SIGNATURE PAGE) ONLY AND RELEASE OF LIABILITY TO: Glena Tharp c/o Main Street Odessa P O Box 4398 Odessa TX 79760.**

1. Contestants must be a female at least 17 years old by day of pageant and no older than 24 years old.
2. **IT IS VERY IMPORTANT THAT YOU ARRIVE EARLY ENOUGH TO PRACTICE YOUR ROUTINE/REHEARSAL.** To maintain fairness, all girls should have the same amount of practice and exposure to the public. This is your responsibility. **REHEARSAL/PRACTICE TIME IS VERY LIMITED, YOU MUST BE ON TIME. All rehearsals will be at Shout Cheerleading with Welton Blaylock; schedule to be advised.**
3. The pageant day will be full; arrangements need to be made with your school or job to be off on this day.
4. Miss Firecracker Fandango will be involved in many areas of future Firecracker Fandango events, as requested. She may award ribbons/prizes and make announcements for entertainment on the stages, make appearances, judge other contests and any number of other duties if her time permits. A chaperone will accompany the queen. She will be allowed to participate in and represent Firecracker Fandango at other community events, appear in the Jaycees "Independence Day Parade" and the Heritage Holiday's "Parade of Lights" with the permission of the Director in charge during her year as **"MISS FIRECRACKER FANDANGO"**.
5. During her year of reign, Miss Firecracker Fandango may have the opportunity to interview live on local TV stations after the pageant, as requested. Miss Firecracker Fandango and runner-ups will need to sign and return (by mail) the scholarship forms within 7 days after the Pageant. These will be in your packet that you receive when the Pageant is over. Remember to notify the Scholarship Board when you have chosen the college or university you will be attending; by doing so your scholarship money will be waiting for you when you register. This is your responsibility, not the Firecracker Fandango Committee, Directors or Main Street Odessa.
6. No gum chewing or smoking during pageant activities.
7. The City of Odessa and Main Street Odessa will not be liable for any accidents or stolen articles during rehearsal/practice or other Firecracker Fandango activities. Every precaution will be taken to insure your safety and that of your personal belongings. All contestants must sign a "Release of Liability" form.
8. **NO ONE WILL BE ALLOWED IN THE DRESSING ROOM AT ANY TIME BEFORE, DURING OR AFTER THE PAGEANT EXCEPT FIRECRACKER FANDANGO COMMITTEE AND CONTESTANTS. THIS WILL BE STRICTLY ENFORCED.**
9. All decisions of the judges will be **FINAL**
10. In the event that Miss Firecracker Fandango is unable to represent Firecracker Fandango at certain events, the first runner up will be asked to replace her.
